FORMATTING OF THE RESOLUTION PAPERS

- The draft resolution should be written in font "Times New Roman", size 12, line spacing 1.50.
- 2. Preambulatory clauses shall start with italic preambulatory phrases and end with commas.
- 3. Operative clauses shall start with underlined starting phrases and be appropriately numbered. Its sub-clauses <u>should not</u> start with operative phrases.

The draft resolutions should be punctuated taking the sample resolution as the example.

ii. supporting indigenous entrepreneurs

- iii. publishing new legal policies upon the matter,
- b. encouraging fostering collaborations between:

i. heritage professionals

ii. community organizations

iii. cultural institutions,

c. increasing the number of incorporation of indigenous cultures and languages in order to:

i. celebrate the rich and diverse nature of the cultures

ii. encourage cross-cultural communication

iii. promote understanding among people and a more inclusive society; /Operative Clause

8. <u>Wishes</u> to remain actively seized on the matter. /Last Operative Clause
